 - 1. 23 members and guests present. December minutes presented.
 - a. Sara Fosburg moved to accept. Brittny Bommarito second. Motion passed.

 - 1. The Michigan FFA Association's account balance as of February 29th is \$148,547.88. All convention bills are outstanding. The balance in our contingency fund as of February 29th is \$169,467.67.

 - a. Mr. Kovach treats to Broiler Contest as a class project and uses it as a recruitment event
 - Currently, the rules for the contest state that all students participating should be FFA members
 - 1) Executive decision made by Dr. Showerman and Mr. Wyrick to charge the finders fee for students who participated that were not members
 - c. Appeal: The Broiler Contest is a good recruitment project. The contest is treated as an experimental project in class. Close to 100% of the students participate every year. Chesaning is not on the affiliate fee program. Advisor can only recommend that students become FFA members. 11 students (out of 60) did not pay dues. These students did not come to the contest but their names were submitted on the report. Mr. Kovach does not believe that the chapter should have to pay dues for students that are not/do not want to FFA members.
