I. Call to Order

III. Secretary's Report

The minutes from the last meeting were submitted by FFA State Secretary Amanda Sollman for review. There was one change.

IV. Treasurer's Report

FFA State Treasurer Kate Krepps reported that there was \$150,912.84 in the FFA account and that there is approximately \$30,000 in outstanding bills.

V. Michigan FFA Association

a. State Officer Report

The 07-08 State Officer Team presented a slide show highlighting many of their activities throughout the year. Alex Henry mentioned some of the activities that

the team has been up to, including their DTE visit and the Ohio State Convention, and thanked the Board for their time and assistance over the year.

b. Advisor's Report

Dr. Randy Showerman discussed that Skills contests went well, with over 1800 students participating.

He went over the spreadsheets of outstanding bills and requested that Regional Representatives try to contact those schools and FFA chapters that have an outstanding bill.

The Michigan Association of Agriscience Educators will be organizing the Summer PDI Conference organization and registration. Fall PDI will be conducted as usual. Winter PDI will be organized and handled by the Michigan Horticultural Teachers Association.

A Collegiate FFA chapter at MSU has officially been organized. There were 35 members at the first meeting. Alex Henry explained that the purpose behind Collegiate FFA was to bridge the gap between high school membership and Alumni membership and to supplement the Association in their various activities.

Dr. Showerman recognized several Board members who will be ending their terms. Megan Merrill and Tom Smith will be ending their current term, but have agreed to serve another term on the Board. Alyn Kiel and Tom Condon have finished their term and will be leaving the Board. The Board thanked them for their service.

c. Executive Secretary's Report

Mr. Dave Wyrick reiterated the success of Skills contest and the establishment of Collegiate FFA.

He noted that the State Officers have been very busy with banquets and their visit to DTE Energy. He presented the State Officers with their retiring officer plaques.

VI. Michigan FFA Alumni

Although Mr. Dave Armbruster was absent, Alex Henry and Kate Krepps reported that, at the last Alumni meeting, they chose to look at creating strategic goals, planning, spreading out the workload, coming up with a solid definition of what Alumni is, and working to grow.

The Alumni also awarded scholarships to high school members attending Michigan State University.

VII. Michigan FFA Foundation

Megan Hirschman reported on the following events and respective dates:

 The 08-09 State Officer Team will be doing three days of business and industry visits around the state as well as visiting several chapters and interacting with members.

Megan also reviewed the most current Foundation financial information with the Board.

VIII. Standing Committee Reports

a. Financial Committee

Committee chair, Tom Smith, reported that he contacted the Dean Armstrong (College of Agriculture and Natural Resources) via e-mail and telephone to discuss the \$80,000 in the Higher Education budget for FFA. He received an e-mail from Dean Armstrong on April 2.

The Dean stated that Michigan State University does not support earmarks made by the legislature and that, while it was boilerplate language, it is not a line item.

Dean Armstrong pledged \$18,000 for State Convention, an additional \$6,000 post-Convention, has committed \$80,000 as of July 1. He also stated in his e-mail that the CARRS Department is hiring a new Ag Education specialist and tenure position.

The Finance Committee expressed interest in meeting with the Dean in person in June with the current FFA State President, the President-elect, Treasurer and a teacher representative.

There will be a request to Dr. Wright, Interim Chair of CARRS, to make a statement clearing up all questions regarding funding and the two new specialist positions.

Dr. Showerman suggested that a fact sheet be created to show how the Michigan FFA Association is funded,

Beth Stuever requested that, in the event of Dr. Wright not being hired as the permanent Department chair and a new chair being hired, that an FFA Board of Directors representative be at the table during the hiring process.

Dustin Grezeszak moved to find the old fact sheet about Association budgeting, date it, attach Dr. Wright's clarification statement, and send it out to current and

up-coming State Officers along with the agriscience teachers. Second. Motion carried.

q. 2007-2008 State Officer Team Recommendations

The State Officer team recommended the following:

- National FFA
 - Due to finding that National delgates have not been as informed as they could be, hold a meeting between the 2007 delegates and the 2008 delegates to teach them about the delegate process
 - Hold a meeting between the 07-08 President and 08-09 President and Vice-President to teach them about the committee/delegate process for SPC
 - Have the 08-09 team nominate an individual (current or past state officer) for the 2009 National FFA Convention Nominating Committee (noting that Michigan cannot have a Nom Comm member in 2008)
- Re-District/Re-Region
 - The team supports the re-regioning/re-districting of the state as determined by the state Association
- Update Michigan FFA Website
 - Update the Michigan FFA website in order to better reflect current websites as well as make it more easily accessible to members and advisors
- State Convention
 - Move the keynote speaker to before the Stars Over Michigan Pageant in the Convention program, in order to increase attendance for the speaker
 - In order to save money and recognizing the technological talents of many current and former FFA members, the State Association could hire Collegiate FFA to do Convention videos in-house (except Stars videos)
 - Have the State Association provide copies of all Stars and State
 Officer videos to those individuals as a keep-sake
 - Hire or attempt to get a volunteer to video tape a live-feed of Convention to be shown on the side screens during sessions
 - Discuss the possibility of giving Regional Vice-Presidents the opportunity to do opening ceremonies for one session per Vice-President during Convention
 - o Explore options to keep members in the Convention sessions
 - Send Convention invitations to every state Association
 - Continue making a video recognizing the National competitors and National application finalists
 - Develop videos to note the highlights of the session to be shown during Convention pre-sessions
 - o Explore options to increase attendance at State Convention workshops or explore reducing the number of workshops held
 - Have State Officers stay on campus instead of in a hotel during State Convention, in order to save money and increase efficiency.

This then opens the option to supporting rooming for visiting State Officers

- State Officer Interviews
 - Create a bank of questions to be used for Regional level State Officer Interviews
- Contest Training
 - Develop training sessions for teachers during PDI for Horse,
 Dairy, and Livestock Evaluation contests
- Ag Expo
 - o Develop an Ag Expo booth for the Michigan FFA Association
- Student Leadership Training
 - Explore ways to increase attendance at SLCCO or other options for regional leadership training
 - o In order to enhance effectiveness of Regional Camps, develop a template for curriculums for those regions that would like it, as well as review camp curriculums before awarding regional grant money
- Board of Directors
 - The team supports and encourages the continuation of the Diversity Task Force
 - Have the Awards and Activities Committee explore ways to enhance the existing student conference programs such as the MFB Career Conference
 - o By 2010, revamp the State Officer election process and look at the number of State Officers elected
