• Michigan FFA CDE Policy During COVID-19: With the postponement of the April 17th Career Development Events a new plan to select the participants to represent Michigan FFA at the National FFA contests must be devised. Every effort will be made to hold a state level contest for those

events that are held at the national level but the following requirements must be met:

- Due to the National FFA certification date requirement all contests must be completed by August 1st, 2020.
