- "Black slacks and black socks/nylons or black skirt and black nylons
 - Skirt should be a minimum of knee length
 - Slacks should be full length"

Language used in contest rules prior to proposal:

"Female members: Black skirt or dress slacks, white-collared blouse, official FFA blue scarf, black dress shoes with a closed heel and toe, black nylon hosiery or socks, official FFA jacket

[&]quot;Mr./Madam Timekeeper, this concludes our presentation."

zipped to the top and worn in the manner prescribed by the National FFA Constitution. (The skirt is to be at least knee length, hemmed evenly across the bottom, with a slot no longer than two inches above the knee, excluding the kick pleat).

Male members: Black dress slacks, white-collared shirt, official FFA tie, black dress shoes, black socks, and official FFA jacket zipped to the top and worn in the manner prescribed by the National FFA Constitution. *Junior high FFA members are allowed to wear FFA jackets, but it is optional. Participants in junior high contests should not be judged differently for wearing or not wearing a jacket."

Official Description will be the following, taking effect in 2024:

"Official Dress for an FFA member includes:

- An official FFA jacket zipped to the top.
- Black slacks and black socks/nylons or black skirt and black nylons.
 - Skirt should be a minimum of knee length
 - Slacks should be full length
- White collared blouse or white collared shirt.
- Official FFA tie or official FFA scarf.
- Black dress shoes with closed heel and toe.

Note: Medical or cultural adjustments to required official dress may be made with prior approval of contest/event chair. Also, appropriate personal protective equipment may be used with Official Dress. Junior high FFA members are allowed to wear FFA jackets, but, it is optional. Participants in junior high contests should not be judged differently for wearing or not wearing a jacket."
