

OUTSTANDING JUNIOR APPLICATIONS

2025 Requirements

In addition to the checklist in AET, Outstanding Junior applications are also manually checked in the Michigan FFA Office to ensure that the remaining requirements are met. You can utilize this guide to identify the components that are manually verified. There is also an example application that includes additional hints and information throughout to aid you in completing your application.

Members of a four-year program

- Show FFA membership since **2023** (or earlier)
- Show a **valid SAE** and supporting records for **at least one year**
- A **valid SAE** must be connected to **agriculture, food, and natural resources (AFNR)**
- All SAEs must be classified as the correct type (**entrepreneurship, placement, or research**) and have appropriate supporting records
- All SAEs must include a description** that describes what the project is and **how it is connected to (AFNR)**
- Have participated in a **minimum of three** leadership/FFA activities **above** the chapter level
- 10 hours** of community service, with descriptions for each entry
- Service projects must include a description** and **cannot** be to FFA chapter, family members, or teaching/participating in religious services.

Members of a two-year program

- Show FFA membership since **2024** (or earlier)
- Show a **valid SAE** and supporting records for **at least one year**
- A **valid SAE** must be connected to **agriculture, food, and natural resources (AFNR)**
- All SAEs must be classified as the correct type (**entrepreneurship, placement, or research**) and have appropriate supporting records
- All SAEs must include a description** that describes what the project is and **how it is connected to (AFNR)**
- Have participated in a **minimum of one** leadership/FFA activities **above** the chapter level
- 10 hours** of community service, with descriptions for each entry
- Service projects must include a description** and **cannot** be to FFA chapter, family members, or teaching/participating in religious services.

Chapter Information

Be sure all SAE projects are classified as the correct type (placement vs. entrepreneurship). **If enterprise is owned/purchased by applicant, it cannot be listed as placement, it must be listed as entrepreneurship.**

Language such as "groomed **my** horse" and "harvested **my** garden" will lead reviewers to think the applicant owns the project and it should be classified as entrepreneurship.

If the project is in fact placement, be sure to clarify in description that someone else owns the enterprise.

For every SAE project listed (both entrepreneurship and placement), in addition to the employer/project name, be sure to include a description. The description must be written so that an outside reviewer can understand:

1. What the project is and
2. How it is related to agriculture, food, or natural resources.

Descriptions should include a description of the project and the student's responsibilities.

Here's how to add/edit an SAE description:

Go to your Journal > Project/Experience Manager (SAE). For each project, under the resources column, there is a clipboard icon. Click the clipboard: Then enter the description into the open field and click save. Repeat these steps for each project.

A valid SAE must be connected to agriculture, food, or natural resources. It cannot duplicate other records or activities in the application. The following **cannot** count toward SAE requirements:

- Competing or preparing for CDE/LDE - this is an FFA activity
- Anything also listed as an FFA activity or community service in the application - hours cannot be duplicated across sections of the application
- Working on the degree application itself

Supervised Agricultural Experience - Entrepreneurs

An entrepreneurship SAE must have a unit of measurement when indicating the size/scope of the enterprise. Ex: "heads", "acres", "bushels", etc.

For both a **four-year** and **two-year program**, students must show at least **one year** of involvement and supporting records in a valid SAE.

SAEs can be any combination of entrepreneurship, placement, or research for any year.

Please see additional notes above on what is required for a project to be considered a **valid SAE**.
